Terms and Conditions

Welcome to the Tempo August 2024 Prize-Draw offered by Tempo Limited ("Tempo, we, or us"). The terms and conditions that apply to the prize-draw are set out below. By entering the prize-draw, you agree to these terms and conditions. These apply in addition to our Standard Terms and Conditions (available [here](#)) and any other terms that may apply to you as a Tempo customer.

Overview of Prize-Draw

Enter the draw to win a prize comprising:

- a \$500 boost to your Tempo investing goal;
- the Curve Diary;
- the Barefoot Investors book; and
- a Sugar Dealer brownie.

Read on for details on how to enter the prize-draw.

Eligible persons

The prize-draw is open to eligible persons. To be an eligible person, you must be:

- over 18 years old;
- a New Zealand resident; and
- either be an existing Tempo customer or meet the criteria to become one if you win the prize-draw.

How to enter

You will receive a single entry to the prize-draw by following our Tempo Instagram account, liking our prize-draw Instagram post and tagging a friend on the Instagram post.

You can then receive additional entries for each additional friend that you tag on our Instagram post.

You can also receive a further additional entry by sharing the prize-draw post on your Instagram story and tagging the Tempo Instagram account.

There is no maximum number of entries per person.

Entry period

Entries will only be accepted during the entry period. The entry period runs from 12am on Thursday, 1 August 2024 to 5pm on Friday, 30 August 2024 (inclusive).

The prize-draw

The prize-draw will take place after 5pm on Friday, 30 August 2024. There will be one winner only. We will notify the winner by email, phone, or direct message within 5 business days of the prize-draw taking place.

The winner should expect to receive the diary, book and brownie within 10 business days of being contacted by us.

In order to receive the \$500 boost towards their Tempo goal, the winner will either need to:

- be an existing Tempo customer with an investing goal set up within the Tempo app; or
- join Tempo (by downloading the Tempo app, opening a Tempo account and passing our customer onboarding checks) and then set up an investing goal within the Tempo app.

The \$500 boost will be credited to the winner's Tempo investing goal as soon as reasonably practicable.

If the winner is not an existing Tempo customer and is not able to join Tempo and set up an investing goal within 20 business days of the prize-draw for any reason, we reserve the right to draw a replacement winner in respect of the \$500 boost component of the giveaway prize.

Our decision is final and no correspondence will be entered into. Prizes are not exchangeable or refundable.

Tagging your Instagram account if you're the winner

By entering the prize-draw, you acknowledge and agree that if you are the winner, we may tag your Instagram account in an Instagram story and/or post announcing the winner.

Other things to know

Entry into the prize-draw is limited to New Zealand residents only. Employees of Tempo (and its related companies) are not eligible to enter.

Just like any payments that Tempo customers make towards their investing goals themselves, the \$500 boost will be invested in the fund mix for the winner's goal.

We may also refuse to accept any entry made by tagging us on Instagram that contains any misleading, offensive, abusive, unlawful or other inappropriate language or other content.
