Fund update for quarter ending 31 December 2023

This fund update was first made publicly available on 13th February 2024.

What is the purpose of this update?

This document tells you how the Tempo NZ Companies Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Forsyth Barr Investment Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Tempo NZ Companies Fund invests in the Octagon New Zealand Equities Fund which invests mostly in New Zealand shares, and can invest in Australian listed shares, where the company has meaningful operations in New Zealand, aiming to achieve positive long-term returns.

Investors in the Tempo NZ Companies Fund are charged fund charges. Based on the PDS as at 7th August 2023 these charges are:³

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds), although no such fees currently apply. Example of how this applies to an investor⁶

Phoebe had \$10,000 in the fund since its inception on 16th August 2023 and did not make any further contributions. At the end of December 2023, Phoebe incurred a loss after fund charges were deducted of -\$83 (that is -0.83% of their initial \$10,000). This gives Phoebe a total loss after tax of -\$87 for the period.


What does the fund invest in?

Notes

- 1. This fund was launched on 16th August 2023. We've calculated the risk indicator using market index returns data for periods before that date, and actual fund returns data afterwards. Using market index returns means that the risk indicators may provide a less reliable indicator of the potential future volatility of the funds. If a fund mainly invests into another fund with a higher risk indicator, we use that higher number.
- 2. Because the fund has not been in existence for a full year as at the relevant date, we have not included annual return figures. We have however included market index returns.
- 3. The fund was launched less than 12 months ago, so these are the fund charges that will be charged, rather than the fund charges that were charged in the most recent scheme year.
- 4. These charges are inclusive of GST.
- 5. The manager's basic fee is made up of a flat Tempo fee of 0.85% plus an underlying fund fee of 0.35%. We are also the manager of the underlying fund.
- 6. Please note that because the fund has not been in existence for a full year as at the relevant date, this example and the returns shown are for the period since inception, not annual figures.
