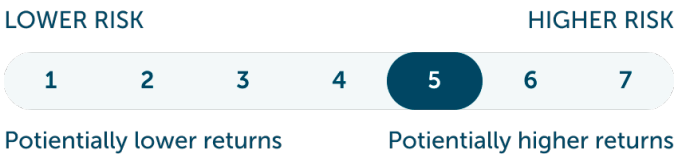
### Description of this fund

The NZ Companies Fund aims to achieve positive long term returns by investing in the Octagon New Zealand Equities Fund which invests mostly in New Zealand shares, and can invest in Australian listed shares, where the company has meaningful operations in New Zealand.

### What are the risks of investing?

Risk indicator<sup>1</sup> for NZ Companies Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Investors in the NZ Companies Fund are charged fund charges based on a percentage of the value of the investments in the fund. As at 31 December 2024 these are:<sup>2</sup>

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds), although no such fees currently apply. ### Example of how this applies to an investor

Phoebe had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Phoebe received a return after fund charges were deducted of \$1,010 (that is 10.10% of their initial \$10,000). This gives Phoebe a total return after tax of \$921 for the year.

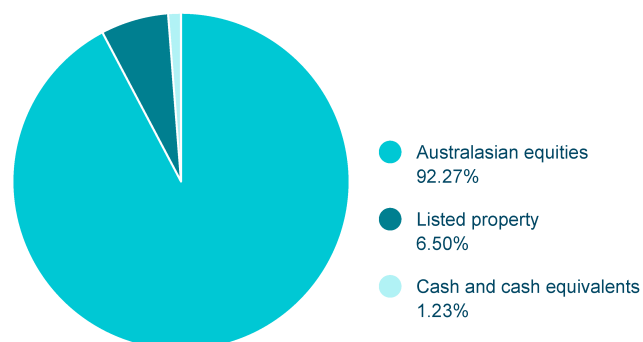

## Notes

1. This fund was launched on 16th August 2023. We've calculated the risk indicator using market index returns data for periods before that date, and actual fund returns data afterwards. Using market index returns means that the risk indicators may provide a less reliable indicator of the potential future volatility of the funds. If a fund mainly invests into another fund with a higher risk indicator, we use that higher number.
2. The fund has not been in existence for the whole of the most recent scheme year, so these are the fund charges that will be charged, rather than the fund charges that were charged in the most recent scheme year.
3. These charges are inclusive of GST.
4. The manager's basic fee is made up of a flat Forsyth Barr fee of 0.85% plus an underlying fund fee of 0.35%. We are also the manager of the underlying fund.
