
Description of this fund

The Tempo Gold Fund invest in an international passively managed exchange traded product which invests in or tracks the price of gold.

What are the risks of investing?

Risk indicator¹ for Tempo Gold Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds), although no such fees currently apply. See the PDS for more information about fees. Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor⁷

Phoebe had \$10,000 in the fund since its inception on 16th August 2023 and did not make any further contributions. At the end of September 2023, Phoebe incurred a loss after fund charges were deducted of -\$328 (that is -3.28% of their initial \$10,000). This gives Phoebe a total loss after tax of -\$353 for the period.



Notes

- 1. This fund was launched on 16th August 2023. We've calculated the risk indicator using market index returns data for periods before that date, and actual fund returns data afterwards. Using market index returns means that the risk indicators may provide a less reliable indicator of the potential future volatility of the funds. If a fund mainly invests into another fund with a higher risk indicator, we use that higher number.
- 2. Because the fund has not been in existence for a full year as at the relevant date, we have not included annual return figures. We have however included market index returns.
- 3. The LBMA Gold Price has been used because there is no appropriate market index or peer group index for the Tempo Gold Fund. However, because it is the price of the commodity itself, the LBMA Gold Price PM USD is the most appropriate index for benchmark comparative purposes for a fund that indirectly invests in or track the price of gold.
- 4. The fund was launched less than 12 months ago, so these are the fund charges that will be charged, rather than the fund charges that were charged in the most recent scheme year.
- 5. These charges are inclusive of GST.
- 6. These charges include the management fees of underlying funds where we are not the manager. In order to estimate these charges, we take into account the proportion of the Tempo Fund that is invested in the underlying fund. We also consider the public disclosures for the underlying fund about its management and administration charges. We have assumed that these will not change. We review all these estimates on an annual basis.
- 7. Please note that because the fund has not been in existence for a full year as at the relevant date, this example and the returns shown are for the period since inception, not annual figures.
- 8. The iShares Physical Gold ETC is a debt security under EU law which is designed to track the price of physical gold and is secured by physical gold.
